UWMC SEEKS TO INCREASE PROSPERITY BY ADDRESSING THE CIRCUMSTANCES AND ROOT CAUSES THAT LEAD TO MORE THAN 26,000 MCLEAN COUNTY HOUSEHOLDS THAT STRUGGLE FINANCIALLY.
