CONSERVATION - MICHIGAN AUDUBON IS A LEADER IN ESTABLISHING SANCTUARIES IN THE STATE TO PROTECT WILDLIFE HABITAT. THE ORGANIZATION PLAYS A MAJOR ROLE IN GLOBAL EFFORTS TO IDENTIFY AND PROTECT CRITICAL MIGRATION STOP OVSERS AND BREEDING AREAS. THEIR 19 SANCTUARIES AND 4 AFFILIATES MANAGE 5000 ACRES OF IMPORTANT WILDLIFE HABITAT. RIVERS, LAKES, MARSHES, BOGS, FENS, GRASSLANDS, HARDWOODS AND NORTHERN CONIFER COMMUNITIES ARE FOUND IN THESE HABITATS, MANY PROTECTING ENDANGERED SPECIES OF ANIMALS AND PLANTS.
