TO DATE, MANO A MANO HAS CONSTRUCTED 186 CLINICS AND 68 SCHOOLS IN RURAL COMMUNITIES THROUGHOUT BOLIVIA. MANO A MANO'S NETWORK OF CLINICS HAS MORE THAN 1 MILLION PATIENT VISITS PER YEAR (1,389,436 IN 2023), AND PROVIDES ACCESS TO HEALTH CARE FOR MORE THAN 800,000 PEOPLE.
