PREVIOUSLY, THE ORGANIZATION WAS PART OF A GROUP EXEMPTION UNDER THE SISTERS OF ST. JOSEPH OF CARONDELET. THROUGH A POWERFUL COMBINATION OF AUDIOLOGICAL SERVICES AND LISTENING AND SPOKEN LANGUAGE THERAPY, INFANTS AND THEIR FAMILIES ARE PROVIDED THE TOOLS THEY NEED TO HELP THEIR CHILD ACHIEVE TO THEIR FULLEST POTENTIAL. SJI'S THERAPISTS ARE LISTENING AND SPOKEN LANGUAGE (LSL) PROVIDERS THROUGH STATE-APPROVED PART C PROGRAMS. SERVICES ARE FAMILY-CENTERED, AND ROUTINE BASED. UTILIZING A PARENT COACHING MODEL, WE HELP FAMILIES UNDERSTAND THEIR CHILD'S DIAGNOSIS, RECOMMEND AMPLIFICATION, AND LEARN TECHNIQUES AND SKILLS TO HELP THEIR BABY LEARN TO LISTEN AND TALK. SJI'S GOAL IN EARLY INTERVENTION IS FOR CHILDREN TO MAKE ACCELERATED PROGRESS IN LISTENING AND SPOKEN LANGUAGE SKILLS SO THAT THEY ARE ON PAR WITH THEIR PEERS. FOR FYE 6/30/23, SJI SERVED OVER 300 CHILDREN THROUGH THIS PROGRAM.
