IN 2023, WARRIOR-SCHOLAR PROJECT COLLABORATED WITH 25 HIGHER EDUCATION PARTNERS TO PROVIDE COLLEGE PREPARATORY IN-PERSON AND VIRTUAL ACADEMIC BOOT CAMPS AND ONE-DAY COMMUNITY COLLEGE WORKSHOPS TO TRANSITIONING SERVICE MEMBERS AND VETERANS. BOOT CAMP PROGRAMMING SERVED 304 UNIQUE INDIVIDUALS AND 52 UNIQUE INDIVIDUALS WERE SERVED THROUGH COMMUNITY COLLEGE WORKSHOPS. WARRIOR-SCHOLAR PROJECT OPERATED 35 WEEKS OF ACADEMIC BOOT CAMP PROGRAMMING, 33 IN THE SUMMER , AND 2 WEEKS OF VIRTUAL PROGRAMMING IN DECEMBER, AS WELL AS 5 SINGLE-DAY COMMUNITY COLLEGE WORKSHOPS.
