Software Development Dev: Mifos X and Fineract are free & open source financial software developed to build the complete range of financial services required for effective financial inclusion at scale. They are delivered as APIs to enable rapid innovation and reference apps as examples of how to build microcredit microsaving and digital financial service applications. We catalyze and enable upstream contribution to these digital public goods creating a virtuous cycle of a global community collectively maintaining the software. In 2023 we shipped the Mifos X 23.12 release in December which contained significant upstream contributions providing greater scalability and support for greater precision and flexibility around lending and better tools for servicing customers. These upstream contributions have also yielded a brand new and more comprehensive test framework improving the quality and stability of the digital public good and overall developer experience for contributors increasing productivity. Within the Payment Hub EE our opensource payments orchestration software through our GovStack efforts we built in new functionalities around bulk processing of payments an Identity Account Mapping Service which is able to be adopted for use by the opensource community independently of PHEE and an improved user experience. By aligning Payment Hub EE we are enabling financial inclusion for citizens of governments adopting the software through a range of payment methods. Our class of Mifos and Google Summer of Code interns contributed in numerous ways around our web and mobile apps including the launch of Mojafos a tool for streamlining deployment of digital public goods for financial inclusion. We now have a strong suite of digital public goods and an active upstream community to extend and maintain them. We continued participating in the Azure Credits for Open Source Projects for a third year to provide sandboxes to end users to evaluate and test our digital public goods for financial inclusion.

4b (Code:) (Expenses \$ 760,108 including grants of \$ 0) (Revenue \$ 396,634)

Community Development COMM: The global Mifos community is made up of financial institutions local technology partners and volunteers who use support and develop the software respectively. We provide the tools framework governance and infrastructure for global collaboration and conduct outreach & advocacy to reach new users recruit new partners and attract new volunteers. Our customer reach continued to grow with more than 35M clients reached by 500+ institutions. In 2023 we made numerous strides in establishing a deeper presence within the digital public infrastructure movement and demonstrating the viability of our ecosystem through highlighting the impact of numerous deployments of our software at scale. We were selected by the ITU DIAL and GIZ to design and implement the payment-building block specification as part of its GovStack Initiative to enable a whole of government approach around adoption enterprise architecture centered around open source digital public goods. We kicked this project off March of 2023. With a grant from the Co-Develop Fund UNF we also aligned our GovStack work with the G2P Connect interoperability specification to enable interoperability amongst digital public goods and also deepened our collaboration with our digital public goods. We also were a founding member of the Open Wallet Foundation launched by Linux Foundation in February 2023. We continued to refine and strengthen our partner program of local support providers and highlighted some of their successes in 2023 including a use case for lending at scale globally rollout of the SIBI system built on top of Mifos for a nationwide financial inclusion program in Mexico and integration with Pix Instant Payments in Brazil via Payment Hub EE by Fintechendo. All of these projects serve as exemplar case studies and examples for our community to adopt scalable inclusive fintech worldwide. Our commitment to building the next generation of technology contributors in financial inclusion continued with our participation in Google Summer of Code for the 11th year mentoring ten interns and launching our inaugural Mifos Summer of Code program with four interns. Volunteers were a critical part of the community contributing their time to help with product management translations and outreach across the community.

4c (Code:) (Expenses \$ 20,763 including grants of \$ 0) (Revenue \$ 0)

Education Edu: With momentum growing as an active participant in the GovStack G2P Connect and Digital Public Goods Alliance Initiatives a major focus of 2023 was advocacy around interoperability amongst digital public goods for creation of digital infrastructure of payment using Mifos digital public goods for orchestrating payments and managing wallets and accounts enabling the delivery of financial services last mile. We spoke and attended numerous events globally including the MOSIP Country Conversations and G2P Connect Workshop in Bangalore India in March 2023 focusing on interoperability of digital public goods for use cases like digitization of social protection programs. We spoke at two Mojaloop OSS meetings - one in Kigali Rwanda in March and in Lusaka Zambia in October speaking on harmonization and integration between complementary digital public goods to build end to end digital public infrastructure solutions. We also attended the Digital Public Goods Alliance Annual Members Meeting in Ethiopia in November. Aside from the DPI space we actively highlighted the scalability of our open source solutions in the fintech and open source circles by attending Fintech DevCon in Austin and co-leading the fintech track at Community over Code North America in Halifax. We welcomed to our board of directors Shashi Raghunandan and Min Tha Gyaw as two strong advocates for inclusive fintech solutions for governments and last-mile financial institutions. We continued to nurture and grow our community via its Slack space gradually improving upon documentation and volunteer collaboration. Through our Mifos Internships and GSOC involvement we have spent effort mentoring and educating the next generation of open source contributors to enable them to be able to grow and tackle the challenges that need to be addressed for last mile inclusion. Through the GovStack work we have also had multiple opportunities to talk to Governments about the importance of last mile inclusion including face to face engagement with the Egyptian Government and numerous online meetings.
