SINCE INCORPORATION ON AUGUST 8, 2012, THE ORGANIZATION HAS SUPPORTED MORE THAN 475 EMERGING JOURNALISTS THROUGH ITS GLOBAL REPORTING FELLOWSHIPS ACROSS MORE THAN 30 COUNTRIES.
