NOORA HEALTH DEVELOPS CONTENT AND SYSTEMS TO TRAIN AT-RISK PATIENTS AND THEIR FAMILIES WITH HIGH-IMPACT HEALTH SKILLS TO IMPROVE OUTCOMES AND SAVE LIVES. SINCE ITS FOUNDING IN 2014, THE NOORA HEALTH PROGRAM IMPLEMENTED THE CARE COMPANION PROGRAM (CCP) IN 10,937 FACILITIES WHICH INCLUDED 10,088 CLINICS AND 849 HOSPITALS REACHING 5.4 MILLION CAREGIVERS CUMULATIVELY. THE PROGRAM IS RUNNING IN INDIA, BANGLADESH, AND INDONESIA WITH CONTENT AVAILABLE FOR POST-SURGICAL, CARDIAC, ONCOLOGY, NEONATAL/ANTENATAL CARE, AND TUBERCULOSIS. THE PROGRAM CREATES MORE RESILIENT HEALTH SYSTEMS, LOWERS PREVENTABLE COMPLICATIONS, LOWERS RE-ADMISSIONS, AND SIGNIFICANTLY REDUCES ANXIETY FOR CARGIVERS.
