From interactive youth events to insightful book clubs, we created inclusive spaces for exploration and understanding. Empowering our community remains a cornerstone of our mission, we continue to foster empowerment through various initiatives. We hosted the second annual Palestine Way Street Festival attracting over 5,000 community members. We conducted 7 Workshop Wednesdays, cultivated a thriving community garden, and facilitated 4 enriching book clubs. Our commitment to womens empowerment was evident through 11 engaging brunches. We expanded our reach and impact through vital social service initiatives. We conducted 4 blood drives, saving over 200 lives, and organized mutual aid supporting over 100 families
