Future Caucus leads efforts to organize the Congressional Future Caucus, our nation's first and only bipartisan caucus for young members of Congress, and its Hill staff counterpart, the 270+ member Millennial Action Staff Association.

In September 2023, Future Caucus launched the Innovation Lab. The Innovation Lab serves as a hub for policy education and bridge-building on the issues that matter most to the next generation and the future of our democracy.
