BORDER RIGHTS PROJECT EXPROVIDES KNOW-YOUR-RIGHTS TRAINING AND LEGAL ACCOMPANIMENT TO REFUGEES AT THEUS-MEXICO BORDER, EMPOWERING REFUGEES WITH INFORMATION ABOUT THEIR RIGHTS IN THE USASYLUM SYSTEM AND HOW POLICIES LIKE TITLE 42, CBP ONE, AND FAMILY SEPARATION MAYIMPACT THEIR ABILITY TO SEEK ASYLUM. WE SUBMIT REQUESTS FOR HUMANITARIAN PAROLE FORMEDICALLY VULNERABLE ASYLUM SEEKERS, AND CONDUCT HUMAN RIGHTS MONITORING,DOCUMENTATION AND DATA ANALYSIS AT US PORTS OF ENTRY. IN 2023, WE PROVIDED LEGAL ORIENTATION TO OVER 12,600 MIGRANTS,AIDED 193 UNACCOMPANIED MINORS AND ASSISTED 1,259 FAMILIES SEPARATED BY BORDERPATROL AT THE US-MX BORDER.
