THE FOUNDATION ALSO COORDINATES WITH THE APPROPRIATE AUTHORITIES TO ENSURE COMPLIANCE WITH RULES AND REGULATIONS GOVERNING THE CONSTRUCTION OF A MEMORIAL ON FEDERAL LAND IN WASHINGTON, D.C. AS A RESULT OF THESE EFFORTS, THE FOUNDATION RECEIVED AUTHORIZATION FROM THE NATIONAL CAPITAL PLANNING COMMISSION FOR ITS LOCATION ADJACENT TO THE LINCOLN MEMORIAL AND THE VIETNAM VETERANS MEMORIAL AND BEGAN THE DESIGN PROCESS.
