THE MARKET, A FOOD PANTRY, PROVIDED 14,034 IN-PERSON SHOPPING VISITS DURING THE YEAR. A HOME DELIVERY SERVICE PROVIDED 2,727 HOME DELIVERIES TO ABOUT 103 FAMILIES.
