IT OFFERS FREE LEGAL ASSISTANCE AND RESEARCH TO JOURNALISTS AND ATTORNEYS, FILES AMICUS BRIEFS, PUBLISHES NUMEROUS GUIDES AND MATERIALS, AND SPEAKS OUT AGAINST THREATS TO THE FREEDOM OF THE PRESS. THE COMMITTEE UNDERTAKES LEGAL DEFENSE AND RESEARCH PROJECTS IN ALL AREAS OF MEDIA LAW, AND ASSISTS JOURNALISTS AND NEWS ORGANIZATIONS WITH FREEDOM OF INFORMATION AND ACCESS-TO-COURT CASES.
