NIRS provides information to community-based organizations and impacted communities about radioactive wastes, regulatory standards, storage technologies, and management practices. RadiationNIRS works to prevent weakening of radiation standards and address gender and age discrimination in radiation standards, and we provide information to the general public, affected communities, and policymakers about the health impacts of ionizing radiation.
