I. BackgroundAmericans for the Arts Foundation, ("AFTA Foundation") is a nonprofit organization incorporated in the District of Columbia in 2007. AFTA Foundation's mission is to carry out activities to raise funds from grants, contributions, bequest and devises, and support the charitable purposes of Americans for the Arts. This mission is accomplished by distributing grants from one of five established funds.II. Analysis AFTA Foundation qualifies as a "publicly supported organization described under section 170(b)(1)(A)(vi) and therefore as an organization described in section 509(a)(1) because it satisfies the "facts and circumstances test" set forth in section 1.170A-9(e)(3) of the Treasury Regulations.A. Threshold RequirementsAFTA Foundation is eligible for a determination of public support under the facts and circumstances test because it meets the two threshold requirements for consideration. First, the portion of AFTA Foundation's support in 2022 that qualifies as eligible public support is approximately 10.58%, which exceeds the 10% threshold required under Treasury Regulation section 1.170A-9(e)(3)(i). Second, AFTA Foundation's operations ensure that it will continue to attract new and additional public support, as required by Treasury Regulation section 1.170A-9(e)(3)(ii). AFTA Foundation's board has reengaged plans to build (1) a continuous and bona fide program for soliciting funds from the general public, community, membership group involved, and governmental units, and (2) the sources of support provide services directly for the benefit of the general public on a continuing basis, thereby satisfying the other threshold requirement for qualifying as publicly supported under the facts and circumstances test. B. Other Relevant FactorsIn determining whether AFTA Foundation meets the "facts and circumstances test," the Treasury Regulations also provide a list of factors that serve as indicia of whether an organization qualifies as "publicly supported." These additional factors, discussed below, provide further evidence that AFTA Foundation satisfies the facts and circumstances test. 1. Sources of SupportAFTA Foundation receives its public support from a wide variety of contributors and does not depend on a single family for contributions, two facts that provide further support for AFTA Foundation's qualification as a "publicly supported" entity. These donors include tax-exempt entities, for-profit corporations, and individuals. While donors were not actively pursued in 2021-2023, a refreshed AFTA Foundation Board plans to reach out to new donors in the coming years by creating a new strategic plan around the Foundation's direction, members, patrons, etc. 2. Representative Governing BodyThe representative nature of an organization's governing body is also a factor in determining whether it qualifies under the "facts and circumstances test." In considering whether a board is representative, such factors as the members' expertise in the relevant field, their history of leadership in the community and their tradition of public service are relevant. AFTA Foundation's Board of Directors includes a variety of industry leaders with a broad range of experience in fields relevant to AFTA Foundation's public service activities, including humanitarian/economic development, finance, healthcare, medical, marketing/advertising, education, and strategic enterprise planning. The following individuals currently serve on AFTA Foundation's Board of Directors:Julie Muraco, AFTA Investment Committee Chair, AFTA Immediate Past Chair, AFTA Foundation ChairManaging Partner, Praeditis Group LLCJulie C. Muraco is founder and Managing Partner of Praeditis Group LLC, a capital markets & business consultancy working with serial entrepreneurs, UHNW/family offices and foundations & endowments seeking direct and secondary investments and alternative investment strategies. She founded Praeditis Group with a concentration on the "permanent private capital and "impact investment" business models in 2008.Ms. Muraco spent more than 20 years on Wall Street as a vice president with J.P. Morgan's Cash Markets Division, New York City, and as a managing director in the Capital Markets Division of Smith Barney in Chicago and earlier in Cleveland.She is on the Board of Directors of Americans for the Arts, Washington, D.C., serving as immediate past Chairman of the Board of Directors; the Board of Trustees of the Robert Sterling Clark Foundation, New York, NY as Treasurer and Chair of the Investment Committee.
