WHEN POSSIBLE, AMICA CENTER SECURES FREE LEGAL COUNSEL FOR IMMIGRATION DETAINEES, EITHER IN-HOUSE OR WITH A PARTNER LAW FIRM OR LAW SCHOOL LEGAL CLINIC.
