COMMUNITY ORGANIZING CAMPAIGNS - JUJF PLAYS A CRUCIAL LEADERSHIP ROLE IN LOCAL AND REGIONAL ACTIVISM BY ORGANIZING A PASSIONATE AND DEDICATED MEMBERSHIP BASE THAT IS READY TO DEVOTE THEIR TIME AND RESOURCES TO SERIOUS STRUCTURAL CHANGE CAMPAIGNS.
