FAMILY SUPPORT HAS BEGUN TO EXPAND PROGRAMMING TO OFFER PARENT GROUPS FOR MOTHERS OF NEW BABIES, TODDLERS, AND PRESCHOOL-AGE PLAYGROUPS WEEKLY. TLC IS PROMOTING PARENT LEADERSHIP THROUGH PARENT-LED WORKSHOPS SUCH AS BABY-WEARING CLASSES, HOMEMADE TOY-MAKING, AND MORE. IN 2022 TLC DEVELOPED CLINICAL SUPPORT SERVICES OFFERING CHILD PARENT PSYCHOTHERAPY, PLAY BASED THERAPY AND COGNITIVE BEHAVIORIAL THERAPY TO FAMILIES ENROLLED IN FAMILY SUPPORT SERVICES WITH A CHILD SEVEN YEARS OLD AND YOUNGER. IN 2023 TLC SUPPORTED 43 FAMILIES UTILIZING ONE OF THE THREE MODALITIES.

TLC HAS PARTNERED WITH THE LOCAL TEEN SHELTER TO PROVIDE WORKSHOPS FOR ANTI-VAPING CURRICULUM, HEALTHY BOUNDARY SETTING, AND COMPREHENSIVE SEXUALITY EDUCATION.
