IN ADDITION TO OFFERING ENGLISH FOR YOUNG LEARNERS AND TEENS; GENERAL ENGLISH AND ENGLISH FOR BUSINESS PURPOSES FOR ADULTS; AND TEST PREPARATION COURSES FOR STANDARDIZED ENGLISH LANGUAGE EXAMS, AMIDEAST ALSO DESIGNS AND CONDUCTS ENGLISH FOR SPECIAL PURPOSES PROGRAMS TO MEET THE SPECIALIZED REQUIREMENTS OF PUBLIC AND PRIVATE SECTOR ENTITIES, INCLUDING NATIONAL MINISTRIES, INTERNATIONAL AND NONGOVERNMENTAL ORGANIZATIONS, AND BUSINESSES.
