100% of our program participants met the criteria for nursing home placement, but used Circle Center's services instead. These older adults were able to live at home 23,166 days longer at a savings to their family and taxpayers of at least \$2,021,492.84. Family caregivers also reported improved quality of their lives: 99% of caregivers reported that Circle Center has reduced their stress as a caregiver 96% of caregivers reported that Circle Center has had a positive impact on their patience and energy level for caregiving 96% have reported that Circle Center has improved the participant's Quality of Life 95% reported that Circle Center has improved the fulfillment of participant's social, emotional and physical needs 85% report that Circle Center's services are crucial to their ability to keep their loved one at home 94% report that Circle Center has allowed them to continue other life roles 99% report Circle Center has provided information and support necessary to assist loved one's needs ACTIVITIES: Circle Center provides participants with the daily care they need to continue living at home while enjoying an enhanced quality of life through involvement with their peers that includes: daily nursing care, nutritional meals and snacks, social work services, therapeutic activities, cognitive and emotional support, transportation coordination, and specialized wellness programs and services. Circle Center brings older adults together in a social, safe, and services-rich environment where they share experiences and build friendships while benefitting from a daily routine that keeps them active and engaged. Meanwhile, family caregivers receive the respite they need from the 24/7 responsibility of caring for an adult loved one. Caregivers also have access to support groups, educational programs, and other services to assist them with caregiving and improve their coping skills. The Center brings together families from all socio-economic groups. ACCOMPLISHMENTS: Circle Center Adult Day Services, one of first 100 adult daycare centers in the nation, celebrated 47 years of compassionate and innovative services in May 2023. The Center has long set the standard for care in the entire region and is Virginia's most comprehensive in terms of services, its state-of-the-art facility, and its support and education programs for caregivers. Center services are based on a Wellness Model of person centered care including wellness programs like strength training, yoga, arts and crafts, Zumba, and reminiscence activities to stimulate memory; all based on individual needs. Since 1980 the Center has subsidized the cost for those who may otherwise not be able to afford services, through support from foundations, corporations, and individual donors. Circle Center is a provider for the Cardinal Care program (formerly CCC+), managed care for those both Medicare and Medicaid eligible, which serves high risk individuals in a more comprehensive and coordinated way across their acute and long term care needs. Also, most long term care insurance pays for Center services. The Center's goals include continued growth to meet the needs of the rapidly expanding population of older adults aging in place with their families and in neighborhoods across the seven counties and three cities served in 2022-23, while maintaining best practices for the provision of this care provided by its multidisciplinary team of licensed and certified staff.
