In 2023, MSI US provided reproductive healthcare to 23.3M people across Africa, Asia and Latin America, 12.8M of whom had little or no prior access to contraception or abortion care. MSI US averted 16.5M unintended pregnancies and saved 37,500 women's lives. MSI-US engages in dynamic fundraising activities to attract support from individuals, family foundations and estate gifts, in addition to receiving a few larger contributions from professional foundations. We deploy digital marketing, email and direct mail to build a base of supporters, and currently we have an active file of 5,000+ constituents who engage with MSI-US. In 2023, MSI-US received an unusual and unexpectedly large contribution from an estate, which totaled \$82.3M.

Although the decedent contributed a total of \$1.6 million (USD) from 2016 to 2022, the decedent never engaged directly with anyone from MSI-US on the phone or in person. Rather, the decedent at one point requested that they not be contacted in response to a thank-you e-mail sent by MSI-US . The decedent was not an officer, director, employee, or contractor of MSI-US. Furthermore, to MSI-US's best knowledge, the decedent was not related to any current or former MSI-US officers, directors, employees, or contractors. No board members are related by blood or marriage, and no board members during the 2023 fiscal year were are substantial contributors to MSI-US. Finally, MSI-US's activities demonstrate that MSI-US is "publicly supported." MSI-US is a supporting organization of MSI Reproductive Choices, which provides reproductive healthcare services internationally in 36 countries . MSI-US furthers its charitable and educational mission through MSI-US's grantmaking activities that enable MSI Reproductive Choices to bring contraception, safe abortion, post-abortion care, and other reproductive health care services to everyone who wants them. The services provided by the clinics MSI-US supports provide services directly to and for the benefit of the public on a continuing basis. Through this activity, MSI-US furthers the charitable purpose of promoting health.</p>
