COMMUNITY HEALTH PROMOTERS TAKE HEALTH EDUCATION DIRECTLY TO RESIDENTS' HOMES, ACTING AS A BRIDGE BETWEEN HEALTH FACILITIES AND THE COMMUNITY, CONDUCTING HOME-BASED HEALTH SCREENINGS, REFERRING RESIDENTS TO CLINICS FOR VITAL HEALTHCARE SERVICES, AND CONDUCTING FOLLOW-UP VISITS WITH PATIENTS. ADDITIONALLY, GIRLS' EMPOWERMENT ACTIVITIES ARE EMBEDDED ACROSS CFK AFRICA'S HEALTH AND EDUCATION PROGRAMS. CFK AFRICA SUPPORTS ADOLESCENT GIRLS AND YOUNG WOMEN THROUGH A DUAL STRATEGY OF MENTORSHIP AND ADVOCACY. RECOGNIZING FEMALES FACE UNIQUE CHALLENGES IN INFORMAL SETTLEMENTS, CFK AFRICA BUILDS SELF-AGENCY AMONG PROGRAM PARTICIPANTS, PROVIDES THEM WITH ACCESS TO A SUPPORT NETWORK, AND ENCOURAGES THEM TO DEVELOP AND USE THEIR VOICES AND PRACTICE LEADERSHIP, ENSURING GIRLS CAN REACH THEIR FULL POTENTIAL.
