KCMS Foundation works with area physicians, hospitals and healthcare practices to procure donation of medically necessary healthcare services. KCMS Foundation then coordinates that healthcare in partnership with Federally-Qualified Health Centers and safety-net clinics across the metro.

Advocacy - KCMS Foundation works to improve health equity and community health by advancing access to care through Medicaid expansion. Board members are selected to represent communities across the metro to provide special knowledge and expertise in the area of safety-net healthcare, health access and equity, and to represent the population served and the broader community. Availability of Public Facilities or Service and Public Participation: KCMS Foundation provides access to over \$8,000,000 annually in donated, free, healthcare to people who are uninsured and medically underserved in a five-county area. In addition, the organization's volunteers provide access annually to over \$10,000 in free community health education services. Over 900 physicians with specialized knowledge and expertise participate in donation of healthcare and health education programming annually through our WyJo, Metro Care, Retired Physician Organization, and Wellness and Prevention programs, which serve to accomplish the charitable work of the organization. The organization is held accountable for grants provided through philanthropic sources. These grants, whether from public or private sources, and made to support charitable programs that support a broad section of the population; those who are uninsured and medically underserved.
