Through the grants awarded, students have the opportunity to repair damage to ecosystems in their communities and in many cases prevent further deterioration. The students become more connected with their school and community surroundings while gaining the skills needed to apply what they learned in the classroom to situations in their everyday lives that require critical thinking and interpersonal skills.
