CASE MANAGERS PROVIDE HOME VISITATION TO PREGNANT WOMEN, LINKING THEM TO PRENATAL CARE AND OTHER IMPORTANT SERVICES, AND PROVIDE HEALTH EDUCATION AND PARENTING SKILLS UNTIL THE BABY TURNS 18 MONTHS OLD. IN 2023, MATERNAL AND CHILD HEALTH SERVED A TOTAL OF 863 PARTICIPANTS, INCLUDING 534 PREGNANT AND POSTPARTUM WOMEN, 226 CHILDREN AGES 0-18 MONTHS, AND 103 FATHERS.

THE PROGRAM ALSO OFFERS A COMMUNITY BREAST HEALTH INITIATIVE TO PROVIDE SUPPORT TO MEDICALLY UNDERSERVED WOMEN TO RECEIVE MAMMOGRAPHY SCREENING, FOLLOW-UP DIAGNOSTIC SERVICES, AND HEALTH EDUCATION. FINALLY, COMMUNITY HEALTH EDUCATION IS OFFERED TO PROMOTE HEALTHY LIFESTYLES AND IMPROVE HEALTH BEHAVIORS, RANGING FROM HEALTHY COOKING, FITNESS, AND STRESS MANAGEMENT. IN 2023, CBWW SERVED OVER 1,285 PATIENTS AND PARTICIPANTS.
