IN 2023, OUR GRASSROOTS BASE OF OVER 50,000 EMAIL ACTIVISTS AND OVER 23,000 TEXT ALERT SUBSCRIBERS SENT EMAILS AND MADE PHONE CALLS TO THEIR DECISION-MAKERS AND PARTICIPATED IN EVENTS ON ISSUES SUCH AS CLIMATE CHANGE, FOREVER CHEMICALS IN OUR WATER, AND CLEAN ENERGY. THIS RESULTED IN OVER 26,000 ACTIONS TO SUPPORT OUR ENVIRONMENT.
