What is the organization's primary exempt purpose?
 Bethanys Gait Ranch is devoted to equine facilitated therapy and learning programs to benefit active duty, reserve and veteran military personnel and their families. We offer programs to help with Post Traumatic Stress Disorder (PTSD), combat-related stress, and Traumatic Brain Injury (TBI). It is estimated that about 30% of all military personnel returning from war campaigns have experienced some form of PTSD or combat-related stress. We emphasize reintegration to civilian life, and family reunification. We also offer programs for family members who are tangentially affected by these conditions. Our leadership development and platoon building programs help take under-performing personnel to the next level of performance

Describe the organization's program service accomplishments for each of its three largest program services, as measured by expenses. In a clear and concise manner, describe the services provided, the number of persons benefited, and other relevant information for each program title.

28 Lissas Legacy A program we designed specifically for wives of military personnel and first responders. Support is provided through retreats, weekly groups, video chats and Facebook page. Classroom and horse work help wives better understand their husbands, provide them with tools and resources to navigate military/first responder life. They receive further support from a group of like-minded women. We served approximately 40 women in 2023.

29 Resilience Unleashed Equine facilitated psychotherapy (EFP) groups and retreats designed specifically for military personnel and first responders. Three-day retreats include classroom and horse work focused on developing resilience, leadership skills and self-esteem. Eight-week EFP groups are limited to eight participants and focus on PTSD, Combat stress and integrating back into civilian life. We served approximately 35 military/first responders in 2023.

30 Mentorship The Mentorship program is for military and first responders families. Participants and their family members are paired with a mentor and a horse of their choosing. Through learning horsemanship, participants bond with the horse and mentor, providing mental and physical support for the client and the horse. We served approximately 28 clients in 2023
