THE "FLAGSHIP FESTIVAL" IN NEVADA CITY AND GRASS VALLEY OCCURRED VIRTUALLY IN FEBRUARY 2023 AND FEATURED MORE THAN 120 FILMS, SCORES OF GUEST FILMMAKERS, WORKSHOPS, ONLINE ART EXHIBITS, AND CELEBRATIONS FOR THOUSANDS OF ATTENDEES TO THE 11-DAY EDUCATIONAL EVENT. THE "ON-TOUR" PROGRAM, WHICH PARTNERS WITH OTHER NON-PROFIT GROUPS, TRAVELED TO MORE THAN 150 COMMUNITIES THROUGHOUT THE UNITED STATES SHARING INFORMATIONAL AND INSPIRATIONAL FILMS AND STORIES.

ALSO, IT PROVIDED SCIENTIFIC INPUT INTO REGULATORY PROCESSES THAT AFFECT RIVER FLOWS IN THE YUBA BASIN. THE WATERSHED SCIENCE PROGRAM INCLUDES THE RIVER EDUCATION PROGRAM WHICH BROUGHT EDUCATIONAL PRESENTATIONS ON WATER CONSERVATION AND FISH HABITAT TO SCHOOLS IN NEVADA COUNTY AND SURROUNDING COUNTIES. RIVER MONITORING, ANOTHER COMPONENT OF WATERSHED SCIENCE, ENTERED ITS 22ND YEAR, AND CONTINUED TO MONITOR THE WATER QUALITY OF THE YUBA RIVER USING VOLUNTEER CITIZEN-SCIENTISTS TO COLLECT DATA SO THAT ANY POTENTIAL THREATS COULD BE DETECTED. EACH YEAR, MORE THAN 80 RIVER MONITORS COLLECT HIGH QUALITY DATA AT NEARLY 40 SITES.

THIS PROGRAM CONTINUES TO COORDINATE ONE OF THE LARGEST RIVER CLEANUPS IN CALIFORNIA WITH MORE THAN 800 VOLUNTEERS. TO PROMOTE RESPONSIBLE CITIZEN STEWARDSHIP OF THE YUBA, OUR RIVER AMBASSADOR PROGRAM CONNECTS WITH 10,000 VISITORS OVER THE 12 WEEKENDS IN THE SUMMER AT SEVERAL RIVER CROSSINGS NEAR POPULAR SWIMMING AREAS ALONG THE SOUTH YUBA RIVER STATE PARK.
