Each program identifies 12-24 influential leaders to engage in intensive training and receive tools in transformational leadership. Rockwood's Partner Programs that were delivered in whole or in part in 2023 served a total of 431 leaders in 22 3-5 day sessions. Multi-session Fellowships included: Building Power for Healthy Communities; Early Care, Learning and Health Leaders; Documentary Leaders; Equity in Philanthropy; Leaders in Early Childhood (Pre-natal to 3) Education; Leaders in Reproductive Health, Rights and Justice. There were also numerous one-session customized trainings with various funders and partners.
