BASED ON FEEDBACK FROM EDUCATORS, THEY ARE INTERESTED IN TEACHING STUDENTS ABOUT THE GREATER HOUSTON ENVIRONMENT, YET IT HAS BECOME MORE COMMON TO TEACH ABOUT OTHER ENVIRONMENTS DUE TO A LACK OF KNOWLEDGE AND TEACHER MATERIALS. IN 2023, CEC PROVIDED EDUCATOINAL MATERIALS THROUGH THEIR ONLINE RESOURCE DIRECTORY, AND BROUGHT TOGETHER ENVIRONMENTAL EDUCATORS FOR COLLABORATION THROUGH A COMMUNITY OF PRACTICE RUN BY VOLUNTEERS KNOWN AS THE ENVIRONMENTAL EDUCATORS EXCHANGE (EEE)
