CIS-SCT SERVED SIX SCHOOL DISTRICTS AND PROVIDED 4,323 STUDENTS WITH INTENSIVE, INDIVIDUALIZED, HOLISTIC SERVICES. IN ADDITION, CIS-SCT PROVIDED TWO OR MORE SERVICES TO OVER 38,152 STUDENTS. CIS-SCT ACCOMPLISHED THIS IN COLLABORATION WITH 1,590 VOLUNTEERS PROVIDING 39,800 HOURS OF SERVICES AND OVER 475 COMMUNITY PARTNERSHIPS TO MEET THE NEEDS OF STUDENTS AND THEIR FAMILIES.
