WE STRIVE TO CREATE THAT WORLD BY DISMANTLING LEGAL, STRUCTURAL, AND CULTURAL BARRIERS THAT CONTRIBUTE TO GENDER INEQUITY. OUR ORGANIZATION SELECTS CASES BASED ON THEIR POTENTIAL EITHER TO AFFECT BROAD POPULATIONS IN SIMILAR SITUATIONS AS OUR CLIENTS OR TO SET A POWERFUL LEGAL PRECEDENT ON PARTICULAR CIVIL AND HUMAN RIGHTS ISSUES.
