WE ALSO DELIVERED MORE THAN 200,000 POUNDS OF FOOD TO RURAL PARTNER PANTRIES IN GLACIER AND LINCOLN COUNTY AND FACILITATED NUTRITION AND FOOD EDUCATION PROGRAMMING.
