Additionally, MLK50 shed light on housing injustices, covering how landlords and developers were displacing residents for profit. The organization also captured the communitys resilience, documenting joyful events such as a Juneteenth celebration and protests against the expulsion of local representatives. Furthermore, MLK50 expanded its reporting capacity by raising funds to hire new reporters focused on government accountability and public safety
