These include schools community air raid shelters and local teams who manage data for more than 45,000 service locations across the country." Another 20% or so of expenditures are accounted for by our Witness platform: "The Witness platform enables the crowdsourced collection of peoples stories from war and disaster-stricken regions while protecting the identity of individuals at risk and ensuring that such an archive can play an important advocacy role around the world and a historical role in the future ensuring future generations have access to the voices of those living through tragedy today. The program includes the technology platform multi-channel outreach programs and team of staff in Ukraine enabling the daily collection and processing of stories. In addition our team works closely with the ICC to ensure war crimes detailed in such collected accounts are appropriately prosecuted. The platform has enabled the prosecution of hundreds of war crimes by the end of 2023." The third largest program by expenditures in 2023 would be the DE&I Scorecard: "The DE&I Scorecard is a technology platform that monitors global datasets to understand how companies treat their employees according to DE&I metrics. The initiative leverages highly detailed data sets to understand shifts in patterns of team structure management promotion leavers and joiners that can tell an overall story of the commitment to equity. The scorecard currently covers more than 5,000 US companies and is targeted at employees investors and consumers to improve transparency and encourage values-based decision-making."
