PARTNER SHELTERS SERVE COMMUNITIES THAT ARE UNDERFUNDED, POVERTY-STRICKEN, AND OVERLOOKED. THEY ARE IN DESPERATE NEED OF ASSISTANCE FOR THEIR ANIMAL RESCUE PROGRAMS AND THE MAINTENANCE OF THEIR SHELTERS.

CURRENTLY, THESE PROGRAMS OPERATE IN BOGOTA, COLUMBIA AND THROUGHOUT NICARAGUA. VETERINARIANS EXAMINE PETS AND PERFORM SPAY AND NEUTER SURGERIES, WHILE GLOBAL STRAYS STAFF ON THE GROUND BRINGS TOGETHER COMMUNITIES IN NEED OF THESE SERVICES. THE PROGRAM DIRECTOR IS IN CHARGE OF OVERSEEING AND WORKING IN CONJUNCTION WITH STAFF AND VETERINARIANS ON THE GROUND.
