TWO WERE FOR YOUNG READERS, SEVEN WERE IN TRANSLATION, NINE OF THE TEN WERE PUBLISHED FOR THE FIRST TIME AND THE REMAINING TITLE WAS A NEW EDITION OF AN EXISTING WORK. AS OF THE END OF 2023 WE HAVE OVER 150 TITLES IN PRINT AND ELECTRIC FORM, SOLD ACROSS THE COUNTRY AND INTERNATIONALLY VIA RETAIL BOOKSTORES, ON THE WEB, INCLUDING FROM OUR OWN WEBSITE, AND BY OUR DISTRIBUTOR, PUBLISHERS GROUP WEST. OUR AUTHORS COME FROM ALL OVER THE WORLD AND REPRESENT ALMOST 50 COUNTRIES OF ORIGIN AND 30 LANGUAGES.
