THE CALIFORNIA IMMIGRANT POLICY CENTER (CIPC) WAS FOUNDED MORE THAN 25 YEARS AGO BY A COLLABORATIVE OF ORGANIZATIONS IN RESPONSE TO THE 1996 PASSAGE OF HARMFUL FEDERAL IMMIGRATION AND WELFARE LAWS. NOW, CIPC IS A STATEWIDE ORGANIZATION THAT LEADS, DEVELOPS, AND ADVANCES PRO-IMMIGRANT POLICIES. IT IS POWERED BY A STAFF OF POLICY EXPERTS, ADVOCATES, AND REGIONAL PARTNERS SPANNING SOUTHERN AND NORTHERN CALIFORNIA, THE CENTRAL COAST, AND THE CENTRAL VALLEY. CIPC’S MISSION IS TO UPHOLD THE HUMANITY OF IMMIGRANT COMMUNITIES IN CALIFORNIA BY TRANSFORMING SYSTEMS TO ACHIEVE RACIAL, SOCIAL, AND ECONOMIC JUSTICE.

THE CALIFORNIA IMMIGRANT POLICY CENTER (CIPC) ENGAGES IN MOVEMENT BUILDING, ORGANIZING, AND STRATEGIC MESSAGING AND NARRATIVE COMMUNICATIONS TO EMPOWER IMMIGRANT COMMUNITIES ACROSS CALIFORNIA. CIPC MOBILIZES COMMUNITIES BY TRAINING LEADERS AND ACTIVISTS TO ADVOCATE FOR THEIR RIGHTS AND ADDRESS ISSUES IMPACTING THEIR LIVES. CIPC FORMS COALITIONS WITH IMMIGRANT RIGHTS GROUPS, LABOR ORGANIZATIONS, AND COMMUNITY-BASED ENTITIES TO CREATE A UNIFIED FRONT ON CRITICAL ISSUES LIKE WORKERS' RIGHTS, HEALTH, AND IMMIGRANT INCLUSION. ADDITIONALLY, THE ORGANIZATION PRIORITIZES DEVELOPING LEADERSHIP SKILLS WITHIN IMMIGRANT COMMUNITIES THROUGH TRAINING IN ADVOCACY AND PUBLIC SPEAKING, FOSTERING A NEW GENERATION OF ADVOCATES. CIPC ORGANIZES EFFORTS TO ENGAGE LAWMAKERS BY PROVIDING IMMIGRANT COMMUNITY MEMBERS THE TRAINING TO SHARE THEIR STORIES AND ARTICULATE THE NEEDS OF IMMIGRANT COMMUNITIES. CIPC ALSO ADVANCES STRATEGIC MESSAGING, NARRATIVE, AND PUBLIC AWARENESS CAMPAIGNS TO HIGHLIGHT THE CONTRIBUTIONS OF IMMIGRANTS AND RAISE AWARENESS ABOUT THEIR CHALLENGES, AIMING TO SHIFT PUBLIC PERCEPTIONS. THROUGH TOWN HALLS AND FORUMS, CIPC CREATES SPACES FOR COMMUNITY VOICES TO BE HEARD AND COLLECTIVE STRATEGIES TO BE DEVELOPED. THROUGH THESE COMPREHENSIVE EFFORTS, CIPC AIMS UPHOLD THE HUMANITY OF IMMIGRANT COMMUNITIES IN CALIFORNIA BY TRANSFORMING SYSTEMS TO ACHIEVE RACIAL, SOCIAL, AND ECONOMIC JUSTICE.

THE CALIFORNIA IMMIGRANT POLICY CENTER (CIPC) FOCUSES ON PROMOTING HEALTH AND FOOD EQUITY FOR IMMIGRANT COMMUNITIES IN CALIFORNIA THROUGH EDUCATION, RESEARCH, AND RELATIONSHIP BUILDING.CIPC PROVIDES RESOURCES AND WORKSHOPS TO INFORM IMMIGRANT POPULATIONS AND ORGANIZATIONS SERVING IMMIGRANT COMMUNITIES ABOUT THEIR RIGHTS AND AVAILABLE HEALTH SERVICES. THE ORGANIZATION CONDUCTS RESEARCH TO IDENTIFY CHALLENGES RELATED TO HEALTH AND FOOD SECURITY IN THESE COMMUNITIES, USING THIS DATA TO INFORM INITIATIVES AND SUPPORT POLICY DEVELOPMENT.BUILDING STRONG RELATIONSHIPS WITH IMPACTED INDIVIDUALS AND COMMUNITY-BASED ORGANIZATIONS IS CENTRAL TO CIPC'S APPROACH. CIPC COLLABORATES WITH LOCAL ORGANIZATIONS TO ENHANCE OUTREACH AND ENSURE COMMUNITY VOICES ARE HEARD. ADDITIONALLY, CIPC ENGAGES WITH LAWMAKERS TO SHARE RESEARCH FINDINGS AND INSIGHTS FROM THE COMMUNITY, FOSTERING UNDERSTANDING OF IMMIGRANT NEEDS.THROUGH THESE EFFORTS, CIPC AIMS TO CREATE AN INCLUSIVE ENVIRONMENT WHERE ALL INDIVIDUALS HAVE ACCESS TO ESSENTIAL HEALTH SERVICES AND NUTRITIOUS FOOD, ULTIMATELY SUPPORTING THE OVERALL WELL-BEING OF IMMIGRANT COMMUNITIES IN CALIFORNIA.

THE CALIFORNIA IMMIGRANT POLICY CENTER (CIPC) SUPPORTS IMMIGRANT WORKERS IN CALIFORNIA THROUGH ADVOCACY, EDUCATION, COMMUNITY ENGAGEMENT, COLLABORATION, AND ECONOMIC EMPOWERMENT INITIATIVES.CIPC ADVOCATES FOR POLICIES THAT PROTECT IMMIGRANT WORKERS' RIGHTS, ADDRESSING ISSUES SUCH AS WAGE THEFT AND WORKPLACE DISCRIMINATION. THEY PROVIDE EDUCATIONAL RESOURCES TO INFORM WORKERS ABOUT THEIR RIGHTS UNDER LABOR LAWS, EMPOWERING THEM TO SEEK FAIR WAGES AND SAFE WORKING CONDITIONS.BY ENGAGING DIRECTLY WITH IMMIGRANT COMMUNITIES, CIPC GATHERS INSIGHTS INTO THEIR SPECIFIC WORKFORCE CHALLENGES, WHICH INFORMS TAILORED PROGRAMS AND ADVOCACY EFFORTS. THE ORGANIZATION COLLABORATES WITH LABOR UNIONS, WORKER CENTERS, AND COMMUNITY-BASED ORGANIZATIONS TO AMPLIFY IMMIGRANT WORKERS' VOICES AND ENHANCE SUPPORT NETWORKS.ADDITIONALLY, CIPC PROMOTES ECONOMIC EMPOWERMENT THROUGH ACCESS TO JOB TRAINING PROGRAMS AND RESOURCES THAT HELP IMMIGRANTS ADVANCE THEIR CAREERS. THEY ALSO CONDUCT RESEARCH TO IDENTIFY BARRIERS FACED BY IMMIGRANT WORKERS, USING DATA TO ADVOCATE FOR MORE INCLUSIVE LABOR POLICIES.THROUGH THESE COMPREHENSIVE EFFORTS, CIPC AIMS TO CREATE A MORE EQUITABLE LABOR ENVIRONMENT, ENSURING IMMIGRANT WORKERS HAVE THE PROTECTIONS AND OPPORTUNITIES NECESSARY FOR SUCCESS IN CALIFORNIA'S ECONOMY.
