BETWEEN THE TWO LOCATIONS, GENESIS PROVIDED A TOTAL OF 6,814 CHARITY MEDICAL, DENTAL, MENTAL HEALTH COUNSELING, COMMUNITY HEALTH CONSULTATIONS, MEDICATION ASSISTANCE, AND SPECIALTY CARE COORDINATION TO LOW-INCOME UNINSURED INDIVIDUALS AS AN EXPRESSION OF THE LOVE OF CHRIST. THE BREAKDOWN OF SERVICES IS MEDICAL, 2,875; DENTAL, 1,255; COUNSELING, 320; COMMUNITY HEALTH, 2,364; MEDICATION ASSISTANCE, 171; AND SPECIALTY COORDINATION, 370.
