The sponsorship supports an observational clinical research study aimed at validating the application of mouse avatars as a clinically relevant platform for precision oncology and evaluating the clinical utility of the patent-pending CertisAI platform, which uses multivariate analyses and gene expression biomarkers to predict drug response (the "Project"). In partnership with Certis Oncology Solutions, the organization held a fundraising event on August 26, 2023, in La Jolla, CA. The event raised approximately \$128,883 in donations, which were collected by the organization and placed into a restricted fund devoted to the purposes of and for the sole benefit of the project's mission. Funds raised for the clinical cancer research study provides each participant with a personalized, no-cost study that combines genomic profiling with predictive AI and advanced functional testing. In addition to helping inform participants' next-line treatment, data collected through this study could impact thousands of other cancer patients in the future. Fundraising expenses for the event totaled approximately \$13,988; however, these expenses were fronted by Certis and not reimbursed by the organization until 2024. As the organization uses the cash basis method of accounting and no fundraising expenses were paid out in cash by the organization during the tax period, such expenses were omitted from Schedule G, Part II. The expenses will be reflected in the next tax period.
