IN PARTNERSHIP WITH HOUSING AND URBAN DEVELOPMENT, HAWAII RISE FOUNDATION HAS BEEN ABLE TO ASSIST VICTIMS OF DOMESTIC VIOLENCE ABUSE WITH THEIR RENTAL EXPENSES TO HELP GET THEM BACK ON THEIR FEET AND HAVE A SAFE PLACE TO CALL HOME FOR A LONG PERIOD OF TIME. THIS PAYS FOR SECURITY DEPOSIT, RENTAL ASSISTANCE, UTILITY BILLS AND HELPS TO PROVIDE SUPPORTIVE SERVICES TO THE CLIENT THROUGH THERAPY AND COUNSELING. VICTIMS MUST EITHER HAVE A JOB OR BE GOING TO SCHOOL, AND THEIR CHILDREN MUST BE IN SCHOOL TO RECEIVE THESE SERVICES. 80% OF THE DOMESTIC VIOLENCE VICTIMS WE HOUSE, SUPPORT AND ASSIST ARE NATIVE HAWAIIAN WOMEN.

IN PARTNERSHIP WITH KA PA'ALANA PARTNERS IN DEVELOPMENT, WE HAVE BEEN OFFERING TRAUMA INFORMED CARE WORKSHOPS TO OUR PARTNER LEADERS AND PROVIDING FREE COVID TEST KITS TO COMMUNITY MEMBERS, SO PEOPLE HAVE ACCESSIBLE CARE AND RESOURCES. EACH BOX IS FILLED WITH A VARIETY OF SEASONAL FRUITS, VEGETABLES, AND STARCHES, ALL GROWN LOCALLY HERE IN HAWAII.
