THESE OPERATORS, TRAINED TO HANDLE HIGH-STRESS AND CHALLENGING ENVIRONMENTS, BRING CRITICAL RESOURCES, MEDICAL ASSISTANCE, SEARCH & RESCUE SERVICES, AND LOGISTICAL SUPPORT TO THOSE IN NEED.
