In 2023, the organization expanded its receivership program, building on previous successes and broadening its impact. It increased the number of properties under receivership in Tennessee and initiated outreach to develop new programs in Texas and Virginia. A key achievement was establishing the Vacant Property Receivership Consortium in collaboration with academics, other nonprofits, and contacts from multiple states, aimed at increasing knowledge and promoting receivership nationwide. The organization also hosted a Receivership Roundtable in Memphis, Tennessee attracting attendees from across the country. These efforts brought greater awareness to issues surrounding vacant, nuisance, and blighted properties, expanded the organization's geographical influence, and fostered a national network dedicated to promoting receivership as an effective community revitalization tool.
