WEA hosted 96 participants on Outdoor Leadership Experience courses, 10 participants in Outdoor Leadership Training Courses, and certified 6 outdoor leaders through the Certified Outdoor Leader course, and offered a Certified Outdoor Educator course to 8 individuals. WEA was able to almost triple our Associate Membership, increase the number of Lifetime Memberships, and maintain many of our Professional and Organizational Members.
