SPECIALTIES INCLUDE PEDIATRICS, UROLOGY, WOMEN'S SERVICES, NEUROLOGY, PHYSICAL THERAPY, NEPHROLOGY AND DIETETICS. HOPE HAS CONTRACTED WITH VENDORS FOR DISCOUNTS FOR ITS PATIENTS ON IMAGING, LAB TESTS, AND SLEEP STUDIES. IN 2023, HOPE PROVIDED 1239 MEDICAL VISITS OVER 264 SHIFTS.
