28 Recognition & Awareness: In 2023, National Council on Severe Autism (NCSA) sent 119,374 emails through its newsletter and grew its subscriber base by 908 subscribers to 6,947. The NCSA Facebook page had a reach of 304,300, and grew its followers by 2,008 to 14,971. NCSA launched its podcast spotlighting often shunned issues, Autism Confidential, and published 21 episodes in 2023. Additionally, the organization published an Autism Makers list on the website to support products made by and supporting individuals with severe autism, facilitated thought leaders for blog content, and had multiple appearances in media through op-eds and speaking events at conferences and podcasts to raise authentic awareness of severe autism.
