The Escalator Award program provides institutional funding to support and advance women in cardiology by providing training, research grants, mentoring and networking support. The 2023 program awarded 9 grants, totaling \$173,000.

(Code:) (Expenses \$ 230,114 including grants of \$ 0) (Revenue \$ 0)

The CLIMB program provides clinical skills training to women in areas of medicine where they are highly underrepresented. Distinguishing features of the program include small group sessions led by world renown experts, and focused attention on networking among all attendees and sponsors. The 2023 virtual program enrolled over 80 women into 4 distinct learning tracks covering 4 topic areas.

RISE is Women as One's flagship in-person conference, held annually in different locations around the world, focusing on different professional development topics each year. The 2023 RISE program focused on building diversity equity and inclusion consensus among multiple stakeholder organizations and on creating networking and leadership development opportunities for women physicians. Nearly 150 women physicians attended the program hosted in New York City and evaluation results were highly positive, with many attendees noting they felt inspired to pursue their professional goals as a result of attending RISE.

EVENTS & CO-SPONSORSHIPS: Women as One regularly co-sponsors networking events, online educational materials and conferences with external organizations which serve to advance the Women as One's mission of promoting talented women in medicine. These opportunities allow for wider opportunities for women to meet, learn and advance. Examples of this include co-sponsorship of the "Women's Cardiometabolic Health Masterclass" held in Laguna Cliffs, CA in August 2023 and the "Expect the Unexpected: Female Lead Extractor Exchange" webinar hosted by a co-sponsor in December, 2023.

Women as One's Talent Directory collects professional profiles on women physicians who voluntarily agree to be part of this free program. The Talent Directory program allows the organization to use various profile fields to match registrants with ongoing professional opportunities such as speaking engagements, advisory board participation, and research projects. There are currently over 2,500 women registered in the Talent Directory from 99 different countries.

Publications: In connection with the work Women as One does to promote gender equity in medicine, the organization assembles working groups to develop research and publish manuscripts in major academic medical journals. Women as One was involved in the publication of 3 manuscripts in 2023, focused on academic publishing, academic rank and radiation safety for healthcare workers.

Equity Programs: Women as One focused resources on providing education and driving awareness to issues that negatively impact women in medicine. Resources are found on Women as One's website, partner webinars in multiple geographies & template distribution. Examples include an educational series on radiation safety along with the development of a mentorship toolkit and published blog posts on topics related to advancing women's careers.
