HelpAge India - Old age home maintenance-Old age home: Some 3 million elderly in India are also homeless without shelter, uncared for and exposed to the vagaries of nature. These elders are often sick, destitute, abandoned by their families and/or uprooted by disasters. HelpAge India has established model homes for the senior citizens and aged in places to provide refuge to the vulnerable and poor elderly who have no other place to call home. HelpAge supports 300 such old age homes and runs 5 model homes for the aged in India.

HelpAge India's flagship Mobile Healthcare Unit (MHU) program provides sustainable healthcare solutions to elders and their communities in the most remote parts of India as well as in urban slums. Each patient receives an individual patient record which keeps details of treatments and helps monitor progress.
