SECONDLY TO PROVIDE SUPPORT ON THE COMMUNITY LEVEL THROUGH SURVIVOR NETWORK. PEER SUPPORT HAS BEEN FOUND TO INCREASE SELF-ESTEEM AND CONFIDENCE, A SENSE OF CONTROL AND ABILITY TO BRING ABOUT CHANGE IN ONE'S LIFE. THE FINAL APPRROACH IN SUPPORTING SURVIVORS IS THROUGH COMMUNITY COLLABORATIVE. I RISE BRINGS THE COMMUNITY TOGETHER TO SUPPORT THE FIGHT AGAINST VIOLENCE AND EXPLOITATION THROUGH TRAINING, PREVENTION, SYSTEMS CHANGE, AND SUPPORTING ONGOING ANIT-TRAFFICKING INITIATIVES.
